On June 17, 2004, the Nursing Home Administrator Board issued a Final Decision and Order adopting the Stipulation signed by Mr. Radmer and a representative of the Division of Enforcement. In the Final Decision and Order, the Board placed limitations on Mr. Radmer's license to practice as a nursing home administrator.

On September 8, 2005, the Nursing Home Administrator Examining Board considered Mr. Radmer's request for return to full licensure. Based upon the record in this matter, including evidence of Mr. Radmer's full compliance with the limitations, terms and conditions set forth in its Final Decision and Order, dated June 17, 2004, the Board voted to grant Mr. Radmer's request for return to full licensure.

#### **ORDER**

**NOW THEREFORE, IT IS ORDERED** that Mark C. Radmer be, and hereby is granted, a full, unrestricted and unlimited, license (#2959) to practice as a nursing home administrator in the State of Wisconsin.
