The Veterinary Examining Board considered this matter at its meeting on February 23, 2005.

BACKGROUND

1. Respondent, Kenneth J. Martinsek, D.V.M., 4634 West State Street, Milwaukee, WI 53208, was granted a license to practice veterinary medicine in Wisconsin on January 1, 1962.
2. On June 23, 2004, the Veterinary Examining Board adopted a Final Decision and Order pursuant to a Stipulation signed by the parties. In its Final Decision and Order, the Board ordered that respondent complete certain requirements including, but not limited to, completion of certain educational course work.
3. On or about February 23, 2005, the Board received confirmation that respondent has completed all of the requirements set forth in its June 23, 2004 Final Decision and Order.

ORDER

NOW, THEREFORE, IT IS ORDERED that, based upon full compliance with the Board's June 23, 2004, Final Decision and Order, the license (#775) of Kenneth J. Martinsek to practice veterinary medicine in the state of Wisconsin be, and hereby is, restored to full licensure.
