The Veterinary Examining Board considered this matter at it meeting on February 23, 2005.

#### **BACKGROUND**

- 1. Respondent, Kenneth J. Martinsek, D.V.M., 4634 West State Street, Milwaukee, WI 53208, was granted a license to practice veterinary medicine in Wisconsin on January 1, 1962.
- 2. On June 23, 2004, the Veterinary Examining Board adopted a Final Decision and Order pursuant to a Stipulation signed by the parties. In its Final Decision and Order, the Board ordered that respondent complete certain requirements including, but not limited to, completion of certain educational course work.
- 3. On or about February 23, 2005, the Board received confirmation that respondent has completed all of the requirements set forth in its June 23, 2004 Final Decision and Order.

### **ORDER**

**NOW, THEREFORE, IT IS ORDERED** that, based upon full compliance with the Board's June 23, 2004, Final Decision and Order, the license (#775) of Kenneth J. Martinsek to practice veterinary medicine in the state of Wisconsin be, and hereby is, restored to full licensure.
