On April 20, 2005, the Wisconsin Medical Examining Board reconsidered the petitioner's request for full reinstatement of her license (#26004), which was limited pursuant to the Board order dated July, 21, 2004. In support of her request for reinstatement, the petitioner submitted additional information consisting of a follow-up report regarding her completion of the Board ordered continuing education program. Based upon all information of record herein, including the additional documentation about the required continuing education program, the Board finds and makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of petitioner's license without limitation is hereby GRANTED.

In reviewing the materials submitted by petitioner, the Board noted that petitioner's educational program did not include a review of any actual hospital labor and delivery cases since she did not have OB hospital privileges at that time. As a result, the Board strongly recommends that petitioner voluntarily agree to have ten (10) of her OB hospital labor and delivery cases reviewed during a period of six months by a mentor who will submit a performance report to the Board as to quality of the petitioner's practice.
