PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Beverly Ford-Williams (D.O.B. 10-28-1956) is duly licensed as a licensed practical nurse in the state of Wisconsin (license # 24278). This license was first granted on December 8, 1981.
 - 2. Respondent's most recent address on file with the Department of Regulation and Licensing is 3427 N. 23rd St., Milwaukee, WI 53206.
- 3. Respondent was the subject of a previous disciplinary action (LS0208094NUR). That action resulted in a Board Order of a reprimand and payment of \$250 in costs, originally due on or about November 8, 2002. Respondent failed to pay those costs when due, and in fact did not pay those costs until June 28, 2004, after being contacted by the attorney for the Division of Enforcement and being offered a proposed stipulation and order in this case.
 - 4. Respondent consents to the issuance of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Board of Nursing has jurisdiction to act in this matter pursuant to §441.07, Wis. Stats. and is authorized to enter into the attached Stipulation pursuant to §227.44(5), Wis. Stats.
- 2. The conduct described in paragraph 3 above violates § N 7.04(14) Wis. Admin. Code and Respondent is therefore subject to discipline pursuant to § 441.07(1)(d) Wis. Stats.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. Beverly Ford Williams is hereby REPRIMANDED.
- 2. No costs shall be awarded to either party.
- 4. This Order is effective on the date of its signing.
