The Veterinary Examining Board considered this matter at it meeting on May 25, 2005.

#### **BACKGROUND**

- 1. Respondent, Timothy J. Schmidt, D.V.M., 3425 Leo Lane, Racine, WI 53406, was granted a license to practice veterinary medicine in Wisconsin on May 21, 1999.
- 2. On September 29, 2004, the Veterinary Examining Board adopted a Final Decision and Order pursuant to a Stipulation signed by the parties. In its Final Decision and Order, the Board ordered that respondent complete certain requirements including, but not limited to, completion of certain educational course work.
- 3. On April 25, 2005, the Board received confirmation that respondent has completed all of the requirements set forth in its September 29, 2004 Final Decision and Order.

#### **ORDER**

**NOW, THEREFORE, IT IS ORDERED** that, based upon full compliance with the Board's September 29, 2004, Final Decision and Order, the license (#4955) of Timothy J. Schmidt to practice veterinary medicine in the state of Wisconsin be, and hereby is, restored to full licensure.
