ORDER

NOW, THEREFORE, IT IS ORDERED that the limited license of, Mary L. Kucaba (Lic.# 125293), to practice as a registered nurse in Wisconsin is hereby REINSTATED and shall be LIMITED to the additional terms and conditions:

1. Petitioner shall submit satisfactory quarterly work reports from her employer and shall not be employed in a home health care setting for a period of two years.
