On April 14, 2005, the Board of Nursing considered information regarding petitioner's violation of the terms of a board order dated November 5, 2004, which suspended her registered nursing license (#74093) and imposed limitations for her rehabilitation, monitoring and treatment. Based upon all information of record herein, including information from petitioner that she has relapsed and violated the terms of the Board order, as reflected in the report from her therapist, the Board finds and makes the following:

## **ORDER**

NOW, THEREFORE, IT IS ORDERED that the limited license of CINDY L. WIERICHS, RN (lic#74093) to practice as a registered nurse is hereby SUSPENDED. The period of suspension shall be for a minimum of one (1) year.

This order shall be effective five (5) days from the date signed below.
