The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Secretary of the Department of Regulation and Licensing ("Secretary"). The Secretary has reviewed this Stipulation and considers it acceptable.

Accordingly, the Secretary in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. American Security ("Respondent"), is licensed in the State of Wisconsin as Private Detective Agency, license # 062 0016225. This license was first granted to American Security on 08/16/02 and is current through 08/31/06.
- 2. Respondent's most recent address on file with the Department of Regulation and Licensing is 1717 University Avenue St. Paul, MN 55104,
- 3. The Wisconsin registered agent for Respondent corporation on file with the Wisconsin Department of Financial Institutions is CT Corporation System, located at 8025 Excelsior Drive, Suite 200, Madison WI 53717.
- 4. Beginning on or about November 30, 2002, and continuing through September 22, 2003, Respondent allowed Ayman S. Fahmy and Michael Schmidt to practice as private security persons with expired temporary licenses.
- 5. According to Department records, Ayman S. Fahmy (#108-22301) and Michael Schmidt (108-22268) have obtained active private security person licenses. Ayman S. Fahmy's private security person's license was granted on 9/22/03 and is current through 8/31/06. Michael Schmidt's private security person's license was granted on 09/22/03 and is current through 08/31/06.

6. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Department of Regulation and Licensing has jurisdiction to act in this matter pursuant to Wis. Stat. sec. 440.26(6).
- 2. The Department of Regulation and Licensing is authorized to enter into the attached Stipulation pursuant to Wis. Stat. sec. 227.44(5).
 - 3. Respondent has violated:

Wis. Stat. sec. 440.26(1) and 440.26(5r)(c) by allowing two employees to practice as private security persons with expired temporary licenses.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondent, license #062 0016225, be, and hereby is, **REPRIMANDED**.

IT IS FURTHER ORDERED that Respondent pay to the Department of Regulation and Licensing COSTS of ONE THOUSAND FIVE HUNDRED DOLLARS (\$1,500.00).

IT IS FURTHER ORDERED, that costs of **ONE THOUSAND FIVE HUNDRED DOLLARS** shall be submitted within sixty (60) days from the date of this order. Payments shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor**, **Division of Enforcement**, **Department of Regulation and Licensing**, **PO Box 8935**, **Madison**, **WI 53708-8935**.

IT IS FURTHER ORDERED, that in the event that Respondent fails to timely comply with the requirements set forth above, its Wisconsin license as private detective agency (#062 0016225) shall be **SUSPENDED**, without further notice or hearing, until it has complied with the terms of this Order. The illegal employment of unlicensed private security persons will result in further disciplinary action against Respondent's license.

IT IS FURTHER ORDERED, that this Order will become effective upon the date of its signing.
