ORDER FIXING COSTS

On July 12, 2005, the Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board filed its Final Decision and Order in the above-captioned matter by which the section ordered that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding be assessed against respondent. Pursuant to sec. RL 2.18 (4), Wis. Admin. Code, on or about July 21, 2005, the Social Worker Section received the Affidavit of Costs in the amount of \$1,004.69, filed by Attorney John R. Zwieg. On or about July 26, 2005, the Social Worker Section received the Affidavit of Costs of the Office of Legal Counsel in the amount of \$277.53, filed by Administrative Law Judge Colleen M. Baird. The Social Worker Section considered the affidavits of costs on September 28, 2005, and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats., the costs of this proceeding in the amount of \$1,282.22, set forth in the affidavits of costs of Attorney John R. Zwieg and Administrative Law Judge Colleen M. Baird, which are attached hereto and made a part hereof, are hereby assessed against respondent, and shall be payable by respondent to the Department of Regulation and Licensing. **Failure of respondent to make payment on or before October 28, 2005, shall constitute a violation of the Order unless respondent petitions for and the board grants a different deadline.** Under sec. 440.22 (3), Wis. Stats., the Department of Regulation and Licensing may not restore, renew or otherwise issue any credential to the respondent until respondent has made payment to the department in the full amount assessed.
