The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. D'Ann Marie Fletcher (D.O.B. 4/17/63) is duly licensed in the state of Wisconsin as a professional nurse (license #126889). This license was first granted on 7/24/97.
2. On May 24, 2004, respondent diverted meperidine from Bloomer Medical Center, where she was assigned as an agency nurse, without authority.
3. Respondent has a history of opioid dependence. Respondent has been offered the opportunity to participate in a rehabilitation process, and has chosen to surrender her license.

CONCLUSION OF LAW

By the conduct described above, respondent is subject to disciplinary action against her license to practice as a registered nurse in the state of Wisconsin, pursuant to Wis. Stats. §441.07(1)(b), (c) and (d), and Wis. Adm. Code §§ N 7.03(1)(a), (b), (c), (e), and N 7.04(1) and (15).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the SURRENDER of the license of D'Ann M. Fletcher RN to practice as a nurse in the state of Wisconsin is ACCEPTED. Respondent shall not practice nursing in Wisconsin, including under the Nurse Licensure Compact, without reinstating her Wisconsin nursing license.

IT IS FURTHER ORDERED that respondent shall pay the costs of investigating and prosecuting this matter, in the amount of \$300.
