The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department of Regulation and Licensing ("the Department"). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Respondent Mandu Varma d/b/a Manjus Beauty Corner ("Varma") is not and has never been licensed as a barbering and cosmetology practitioner or an aesthetician in the State of Wisconsin pursuant to Chapter 454 of the Wisconsin Statutes.
- 2. Wis. Stat. § 454.04 prohibits any person from engaging in barbering or cosmetology or aesthetics in the State of Wisconsin unless the person has a barbering and cosmetology license or an aesthetician license issued by the Department of Regulation and Licensing, and pursuant to the rules and regulations set forth by the Department.
- 3. Manjus Beauty Corner is not and has never been licensed as a barbering and cosmetology establishment or an aesthetician establishment in the State of Wisconsin pursuant to Chapter 454 of the Wisconsin Statutes.
- 4. Wis. Stat. § 454.08(1)(b) prohibits the practice of barbering or cosmetology or aesthetics outside of an establishment licensed by the Department of Regulation and Licensing, except in the limited circumstances provided in Wis. Stat. § 454.08(1)(a) that are not present in this case.
- 5. On or about September 29, 2004, during an unannounced visit by Division of Enforcement Investigator Willie Garrette, Varma was seen cutting a patron's hair at Manjus Beauty Corner, an unlicensed beauty salon being operated out of the basement of her home.

- 6. On or about September 29, 2004, Varma's husband, Anil Varma, informed Investigator Garrette that Varma had been operating Manjus Beauty Corner for approximately 2 to 3 years out of their home, and provided facials, waxing and haircutting services for compensation.
- 7. Varma understands that she needs a license to practice barbering or cosmetology or aesthetics in Wisconsin, and can only provide such services in a licensed establishment.
- 8. Varma understands that she cannot operate a barbering and cosmetology establishment or an aesthetician establishment out of her home unless and until she obtains an establishment license.

CONCLUSIONS OF LAW

- 1. The Wisconsin Department of Regulation and Licensing has jurisdiction over this matter pursuant to Wis. Stat. § 440.21(1) and (2).
- 2. The Wisconsin Department of Regulation and Licensing is authorized to enter into this stipulated resolution of this matter pursuant to Wis. Stat. § 227.44(5).
- 3. Cutting hair for compensation constitutes the practice of barbering and cosmetology pursuant to Wis. Stat. 454.01(5)(a).
- 4. Providing facials and waxing for compensation constitutes the practice of barbering and cosmetology pursuant to Wis. Stat. § 454.01(5)(b) or the practice of aesthetics pursuant to Wis. Stat. § 454.01(2).
- 5. Respondent Mandu Varma d/b/a Manjus Beauty Corner has engaged in activities that constitute the practice of barbering and cosmetology and the practice aesthetics in the State of Wisconsin in violation of Wis. Stat. § 454.04.
- 6. Respondent Mandu Varma d/b/a Manjus Beauty Corner has engaged in the practice of barbering and cosmetology and the practice of aesthetics in an unlicensed establishment, Manjus Beauty Corner, in violation of Wis. Stat. § 454.08(1)(b).
- 7. Respondent Mandu Varma d/b/a Manjus Beauty Corner has operated an unlicensed establishment in her home, in violation of Wis. Stat. §§ 454.08(3), (4), (5) and Wis. Admin. Code Section BC 3.04.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Respondent Mandu Varma d/b/a Manjus Beauty Corner is ENJOINED and PROHIBITED from the practice of barbering and cosmetology and the practice of aesthetics unless and until she obtains a barbering and cosmetology practitioner's license or an aesthetician license in the State of Wisconsin.

IT IS FURTHER ORDERED that Respondent Mandu Varma d/b/a Manjus Beauty Corner is ENJOINED and PROHIBITED from operating a barbering and cosmetology establishment or an aesthetician establishment unless and until it is licensed as such in the State of Wisconsin.

IT IS FURTHER ORDERED that Respondent Mandu Varma d/b/a Manjus Beauty Corner be, and hereby is, notified that any person who violates a special order such as this, after it is issued under Wis. Stat. § 440.21 may be required to forfeit not more than \$10,000.00 for each offense, and that each day of continued violation constitutes a separate offense.
