PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Wisconsin Medical Examining Board ("Board"). The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this mater adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. George J. Krismer, M.D., (DOB August 15, 1931) is duly licensed as a physician in the state of Wisconsin (license # 12659). This license was first granted on July 15, 1957.
- 2. George J. Krismer's most recent address on file with the Wisconsin Medical Examining Board is 248 McHenry Street, Burlington, Wisconsin 53105.
- 3. At all times relevant to this action, George J. Krismer, M.D., was working as a physician at Aurora Burlington Clinic, 248 McHenry Street, Burlington, Wisconsin 53105.
- 4. An informal complaint received by the Medical Examining Board alleges treatment of a patient with methadone for the purpose of withdrawal from opiate addiction without certification as a narcotic treatment service provider for opiate addiction.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. §448.02, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. §227.44(5).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. George J. Krismer, M.D. will, within 9 months of the date of this Final Decision And Order for Remedial Education, take and complete a one (1) day course consisting of at least 6 hours of Category 1 continuing education course in medical/legal issues involved in prescribing and dispensing of controlled substances and in the treatment of patients with drug dependence. The course attended in satisfaction of this Order must be preapproved by the Medical Examining Board or its designee. George J. Krismer, M.D. will be responsible for locating a course satisfactory to the Medical Examining Board and for obtaining the required approval of the course from the Medical Examining Board or its designee. George J. Krismer, M.D. will within 60 days of completion of this educational requirement file an affidavit with the Medical Examining Board stating under oath that he has attended in its entirety the course approved for satisfaction of this requirement along with supporting documentation of attendance from the sponsoring organization. This affidavit and the supporting documentation of attendance will be filed with:

All certifications, affidavits or other documents required to be filed with the Medical Examining Board will be deemed filed upon receipt by the Department Monitor.

2. George J. Krismer, M.D., will be responsible for paying the full cost of attendance at these courses. George J. Krismer, M.D., will not apply any of the continuing education credits earned in satisfaction of this Order toward satisfaction of his Wis. Stat. § 448.13, biennial training requirements.

IT IS FURTHER ORDERED that:

3. George J. Krismer, M.D., shall, within sixty (60) days from the date of this Order, pay costs of this proceeding in the amount of two hundred dollars (\$200.00). Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to:

- 4. In the event George J. Krismer, M.D., fails to timely pay costs as ordered or fails to comply with the ordered continuing education, George J. Krismer, M.D.'s license (#12659) SHALL BE SUSPENDED, without further notice or hearing, until George J. Krismer, M.D., has complied with the terms of this Order. The Board or its designee will remove the suspension, if provided with sufficient information that George J. Krismer, M.D., is in compliance with the Order and that it is inappropriate for the suspension to remain in effect. The Board in its discretion may impose additional conditions and limitations for a violation of any of the terms of this Order.
- 5. George J. Krismer, M.D., is responsible for compliance with all of the terms and conditions of this Final Decision and Order.

6. This Order is effective on the date of its signing.
