On June 9, 2005, the Board of Nursing reviewed the petitioner's request for reinstatement of her limited her practical nurse license (#10785) in order to complete the clinical portion of the board-approved nurse refresher course. On April 25, 2005, the Board suspended the petitioner's license upon receipt of information that petitioner had been working as full-time nurse for the Reedsburg Physicians Group prior to completion of the clinical portion of the refresher course. Based upon all of the information presented, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the limited practical nurse license of KAREN A. DAVIS (#10785) to permit her to complete the clinical portion of the board-approved nurse refresher course is hereby DENIED.

IT IS FURTHER ORDERED that petitioner may reapply for reinstatement of her limited license eight (8) months from April 25, 2005, which is the equivalent period of time that petitioner worked as a nurse under her limited license before she completed her nurse refresher course.

This order shall be effective upon the date signed below.
