The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### FINDINGS OF FACT

- 1. White's Barber Shop is duly licensed as a barbering and cosmetology establishment in the State of Wisconsin having license #080 0018402. The grant date of White's Barber Shop establishment license is unknown but the license is current until 06/30/05.
- 2. White's Barber Shop most recent address on file with the Department of Regulation and Licensing ("Department") is: 1654 West Hopkins Street, Milwaukee, Wisconsin 53202.
- 3. Alex A. White, date of birth 09/24/57, is the listed owner of White's Barber Shop. According to Department Records, Mr. White is duly licensed as a barbering and cosmetology manager in the State of Wisconsin having license # 081 0021269. This license was first granted to Mr. White on 11/16/87.
  - 4. Mr. White's most recent address on file with the Department is: P.O. Box 510585, Milwaukee, WI 53202.
  - 5. As owner, Mr. White was and is at all times relevant to this action responsible for compliance with Wisconsin

Statutes, Chapter 454 and the Wisconsin Administrative Code for Barbering and Cosmetology Chapter 2.

- 6. On or about August 28, 2002, the Department received a complaint alleging that Mr. White and White's Barber Shop allowed employees to perform barbering and cosmetology services without barbering and cosmetology licenses.
- 7. On or about January 29, 2003, two investigators from the Department performed an inspection of White's Barber Shop. During the inspection, the investigators received business cards that advertised the names of four individuals that were providing barbering and cosmetology services without barbering and cosmetology licenses. The inspection did not reveal any sanitation violations.
- 8. On or about March 27, 2003, the Department received written correspondence from the Respondent acknowledging and apologizing for the unlicensed practice discovered at White's Barber Shop.
- 9. In resolution of this matter, Alex A. White and White's Barber Shop consent to the entry of the following Conclusions of Law and Order.

#### **CONCLUSIONS OF LAW**

- 1. The Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15.
- 2. The Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5),
  - 3. Respondents Alex A. White and White's Barber Shop, have violated:
- a. Wis. Stat. §§ 454.04 (1)(a) and Wisconsin Administrative Code § BC 2.04(1) by allowing four individuals to provide unlicensed barbering and cosmetology services; and
- b. Wisconsin Administrative Code § BC 2.05(1) by advertising barbering and cosmetology services that were to be provided by persons who did not possess barbering and cosmetology licenses.

#### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondents shall jointly and severally pay to the Department of Regulation and Licensing a forfeiture of **FOUR THOUSAND DOLLARS** (\$4,000.00).

IT IS FURTHER ORDERED, that Respondents shall jointly and severally pay costs in this matter in the amount of **ONE THOUSAND DOLLARS (\$1,000.00).** 

IT IS FURTHER ORDERED, that a down payment of **ONE THOUSAND DOLLARS** (\$1,000.00) shall be submitt within thirty (30) days from the date of this order and four more payments of **ONE THOUSAND DOLLARS** (\$1,000.00) w due every three months from the previous payment until the full **FIVE THOUSAND DOLLARS** is paid. Payments shall be n **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED, that in the event that Alex A. White and White's Barber Shop fail to timely submit payment of the forfeiture and costs as set forth above, Alex A. White's barbering and cosmetology manager's license # 081 0021269 and the establishment license for White's Barber Shop (# 080 0018402) **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said costs has

been paid to the Department of Regulation and Licensing and their failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file, 02 BAC 094 be, and hereby is, closed as to all Respondents.
