#### PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

For the purpose of settlement of this matter, Ms. Schultz neither admits nor denies the allegations against her. Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### FINDINGS OF FACT

- 1. Geraldine L. Schultz, RN (D.0.B. 07/09/1940) is duly licensed as a registered nurse in the state of Wisconsin (license #28681). This license was first granted on 1/26/1962.
- 2. Ms. Schultz's most recent address on file with the Wisconsin Board of Nursing is W7089 West Clymet Road, Watertown, WI 53098.
- 3. At all times relevant to this action, Ms. Schultz was working as a registered nurse at Bethesda Lutheran Homes and services, 700 Hoffman Drive, Watertown, Wisconsin.
- 4. On or about July 11,2002 Respondent failed to take the morning blood glucose reading for resident BO, but charted an

a.m. glucose level of 148 for this resident.

- 6. On or about July 11,2002 Respondent failed to take the noon blood glucose reading for resident BG, but charted a noon glucose level of 136 for this resident.
- 7. On or about July 12, 2002 Respondent failed to take the noon blood glucose reading for resident BG, but charted a noon glucose level of 149 for this resident.
- 8. On or about July 18, 2002 Respondent failed to take the noon blood glucose reading for resident BG, but charted a noon glucose level of 142 for this resident.
- 9. On or about July 21, 2002, Respondent failed to take morning blood glucose readings for resident BG, but charted a morning glucose level of 147 for this resident.
- 10. On or about July 22, 2002 Respondent failed to take the morning blood glucose reading for resident BG, but charted a morning glucose level of 138 for this resident.
- 11. On or about July 22, 2002 Respondent failed to take the noon blood glucose reading for resident BG, but charted a noon glucose level of 148 for this resident.
- 12. On or about July 26, 2002 Respondent failed to take the morning blood glucose reading for resident BG, but charted a morning glucose level of 124 for this resident.
- 13. On or about July 26, 2002 Respondent failed to take the noon blood glucose reading for resident BG, but charted a noon glucose level of 146 for this resident.
- 14. On or about July 31, 2002 Respondent failed to take the morning blood glucose reading for resident BG, but charted a morning glucose level of 122 for this resident.
- 15. On or about August 4,2002 Respondent failed to take the morning blood glucose reading for resident BG, but charted a morning glucose level of 138 for this resident.
- 16. On or about August 7, 2002 Respondent failed to take the morning blood glucose reading for resident BG, but charted a morning glucose level of 92 for this resident.
- 17. On or about August 7, 2002 Respondent failed to take the noon blood glucose reading for resident BG, but charted a noon glucose level of 148 for this resident.

#### CONCLUSIONS OF LAW

By the conduct described above Respondent violated 441.07(1), Wis. Stats. and Wis. Admin. Code § N 7.03(l)(a) and N 7.04(4), (6) and (15). Furthermore, the Findings of

Fact set forth above constitute an agency finding within the meaning of sees. 48.685 and 50.065, Wis. Stats.

#### **ORDER**

### NOW, THEREFORE, IT IS HEREBY ORDERED that

- 1. Geraldine L. Schultz shall SURRENDER her license to practice as a registered nurse in the state of Wisconsin (license #28681).
- 2. Ms. Schultz shall return to the Department her current RN registration card, as well as any and all other official indicia of licensure within her possession.

#### IT IS FURTHER ORDERED that:

- 3. Should Ms. Schultz reapply for Wisconsin licensure, the Board may in its sole discretion determine whether, and under what terms and conditions, this license may be reissued.
- 4. This Order shall become effective on the date of its signing.
