#### **PROCEDURAL HISTORY**

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### **FINDINGS OF FACT**

- 1. Respondent Mina M. Khorshidi, M.D. (dob August 4, 1952) is and was at all times relevant to the facts set forth herein a physician and surgeon licensed in the State of Wisconsin pursuant to license # 44766, first granted on July 25, 2002. Respondent is an internist.
  - 2. A the time of this incident, Respondent was working as a physician in New York.
- 3. On April 8, 2004 Dr. Khorshidi entered into a Consent Order with the New York State Board for Professional Medical Conduct that censured, reprimanded, and ordered Dr. Khorshidi to pay a \$7,500 fine for misrepresenting herself to the Suffolk County Department of Health Services as being certified by the American Board for Internal Medicine when, in fact, she knew that she was not.
- 4. A true and correct copy of New York's Consent Order and Consent Agreement and Order are attached to this document as Exhibit A. Exhibit A is incorporated into this document by reference.

### **CONCLUSIONS OF LAW**

- A. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to §448.02(3), Wis. Stats. and is authorized to enter into the attached Stipulation pursuant to §227.44(5), Wis. Stats.
- B. The conduct described in ¶2, above, violated § Med 10.02(2)(q), Wis. Adm. Code. Such conduct constitutes unprofessional conduct within the meaning of the Code and statutes.

#### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is accepted.

IT IS FURTHER ORDERED, that Mina M. Khorshidi, M.D., is REPRIMANDED for her unprofessional conduct in this matter.

IT IS FURTHER ORDERED, that respondent shall pay the COSTS of investigating and prosecuting this matter of SEVEN HUNDRED dollars (\$700) within 30 days of this Order.

IT IS FURTHER ORDERED, that pursuant to §227.51(3) and §448.02(4), Wis. Stats., if the Board determines that there is probable cause to believe that respondent has violated any term of this Final Decision and Order, the Board may order that the license and registration of respondent be summarily suspended pending investigation of the alleged violation.
