On November 21, 2005, the Board of Nursing issued an order erroneously stating that petitioner had requested a stay of suspension of her limited license pursuant to a Board order dated February 2, 2001. Petition has a prior Board order in 2001 which reprimanded and limited her license. She satisfied her 2001 order and had a fully reinstated active license until she was re-disciplined in 2005 on the basis of a new violation and board order. The petitioner's license is currently limited and suspended by order of the Board dated July 14, 2005.

This order is a correction of the scrivener's error and does not alter the terms of the order dated November 21, 2005, which granted a three month stay of the suspension of her limited license.
