PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Respondent George [no middle name] Bolek (dob 1/9/43) is and was at all times relevant to the facts set forth herein a physician and surgeon licensed in the State of Wisconsin pursuant to license #27564, first granted on 7/1/86. Respondent is a general practitioner. Respondent was previously disciplined by the Board on 3/26/98, in file 95 Med 375, for inappropriate prescribing of controlled substances; he was reprimanded and his license was limited to require that he successfully complete a 45 hour course in appropriate prescribing of controlled substances, and a separate course in patient health care recordkeeping. He did complete the required courses, and his license was restored to unlimited status in 3/23/00.

2. Respondent is presently under investigation for injudicious prescribing of controlled substances, without adequate supportive documentation. In resolution of this matter, respondent has agreed to this settlement.

CONCLUSIONS OF LAW

A. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to §448.02(3), Wis. Stats. and is authorized to enter into the attached Stipulation pursuant to §227.44(5), Wis. Stats.

B. The conduct described in ¶2, above violated § Med 10.02(2)(h) and (m), Wis. Adm. Code. Such conduct constitutes unprofessional conduct within the meaning of the Code and statutes.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is accepted.

IT IS FURTHER ORDERED, that the SURRENDER of the REGISTRATION to practice medicine and surgery of George Bolek, M.D., is ACCEPTED, effective at 11:59 PM on the date of this Order. Respondent shall not practice medicine in Wisconsin without being registered to practice.

IT IS FURTHER ORDERED, that respondent shall pay the COSTS of investigating and prosecuting this matter of \$1,800.
