The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Secretary of the Wisconsin Department of Regulation and Licensing (Department) or the Secretary's designee. The Secretary or designee has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department Secretary or designee in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Shannon P. Haggett ("Respondent Haggett"), is registered in the State of Wisconsin with the Department as a I Security Person. Haggett's registration number is 108-0005120. The registration was first granted on July 1, 1997, and expire August 31, 2006.
- 2. Respondent Haggett's last reported address on file with the Department is 10127 W. Forest Home Ave., Apt. 7, Hales Corners, WI 53130.
 - 3. SPS International Corporation (Respondent SPS) is licensed in the State of Wisconsin with the Department as

Private Detective Agency. The license number is 062-0015895. The license was granted on July 2, 1998, and is current throu August 31, 2006.

- 4. Respondent SPS's last reported address on file with the Department is PO Box 761, Hales Corners, WI 5313
- 5. Respondent Haggett operates Respondent SPS and has at all times relevant to this complaint.
- 6. Respondent Haggett reached an oral agreement on behalf of Respondent SPS to provide private security servic Cafe H2O (also referred to as Club H2O), whose address was 7427 West Bradley Road, Milwaukee, Wisconsin.
- 7. Beginning sometime in June of 2002, and continuing until Cafe H2O ceased to do business at some unknown d Respondents SDS and Haggett provided private security services to Cafe H2O.
- 8. At no time during which the Respondents provided private security services to Cafe H2O did the Respondents reduce the oral agreement with Cafe H2O to provide private security services to a written agreement.
 - 9. The Respondents consent to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Secretary of the Wisconsin Department of Regulation and Licensing has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.26 (6).
- 2. The Secretary of the Wisconsin Department of Regulation and Licensing is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44 (5).
- 3. The actions of the Respondents as set forth in paragraphs 7 and 8 of the Findings of Fact in providing private security services to a client without entering into a written agreement with the client before providing services to the client constitutes a violation of Wis. Admin. Code sec. RL 33.06.
- 4. The actions of the Respondents in violating Wis. Admin. Code sec. RL 33.06 constitutes unprofessional conduct as set forth in Wis. Admin. Code sec. RL 35.01 (12m).
- 5. The actions of the Respondents in violating rules promulgated pursuant to Wisconsin Statutes and engaging in unprofessional conduct constitute grounds for taking disciplinary action against the Respondents pursuant to Wis. Stat. sec. 440.26 (6).

ORDER

NOW THEREFORE, IT IS HEREBY ORDERED that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED that Respondent Haggett, whose registration number is 108-0005120, and Respondent SPS, whose license number is 062-0015895 be, and hereby are, **REPRIMANDED**.

IT IS FURTHER ORDERED that Respondents Haggett and SPS jointly and severally pay to the Department of Regulation and Licensing COSTS of One THOUSAND AND SEVEN HUNDRED (\$1,700.00) DOLLARS.

IT IS FURTHER ORDERED, that a payment of **FIVE HUNDRED DOLLARS** (\$500.00) shall be submitted within the (30) days from the date of this order and another payment of **FIVE HUNDRED DOLLARS** (\$500.00) shall be submitted we another thirty (30) days from the date of the last payment until the full **ONE THOUSAND AND SEVEN HUNDRED DOL** (\$1,700.00) is paid. Payments shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event Respondents fail to pay the **ONE THOUSAND AND SEVEN HUNDRED DOLLARS** (\$1,700.00) costs within the time and in the manner as set forth above, then and in that event, and without further notice to the Respondents, Respondent Haggett's registration as a Private Security Person (108-0005120), and Respondent SPS's license as a Private Security Agency (062-0015895) shall be **SUSPENDED** without further hearing and without further Order of the Department Secretary, and said suspension shall continue until the full amount of said costs has been paid to the Department of Regulation and Licensing. Failure to pay the costs shall be considered a violation of this Order by the Department Secretary

IT IS FURTHER ORDERED, that file 02 RSG 040 be, and hereby is, closed.
