### PROCEDURAL HISTORY

- 1. On August 16, 2005, the Department of Regulation and Licensing granted Robert E. Piepenhagen a limited Home Inspector license (#106-1800). The basis for the limitation was a conviction on December 27, 1985 of sexual assault.
- 2. On August 31, 2005, Robert E. Piepenhagen wrote to the Department requesting to voluntarily surrender his license rather than attempt to comply with the conditions of his limited license.

### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that;

1. The Department of Regulation and Licensing ACCEPTS the voluntary SURRENDER of the license of Robert E. Piepenhagen (license #106-1800) to practice as a home inspector in the State of Wisconsin. Respondent shall immediately return all indicia of Wisconsin Licensure to the Department Monitor, Post Office Box 8935, Madison, WI 53708-8935.

This Order shall become effective upon the date of its signing.
