## **PROCEDURAL HISTORY**

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Wisconsin Medical Examining Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

# **FINDINGS OF FACT**

- 1. Timothy H. Werner, D.O. (DOB 11/04/52) is duly licensed to practice medicine and surgery in the state of Wisconsin (license #21-23340). This license was first granted on July 25, 1980. Dr. Werner's specialty is general practice.
- 2. Dr. Werner's most recent address on file with the Wisconsin Medical Examining Board is 622 W. 4th Street, Oshkosh, WI 54902.
- 3. On August 13, 2004, Respondent entered into an Agreed Order with the Texas State Board of Medical Examiners which suspended his license to practice medicine in the State of Texas for a period of not less than 6 months. The factual basis for the imposition of discipline against Respondent in Texas involved: 1) Providing medications to his wife who had a substance abuse problem. Respondent alleged he was attempting to treat his wife in detoxification without having to document the treatment; 2) Allowing his wife to have access to his prescriptions pads; and 3) Failing to be professionally monitored or treated since January 2004 for Bi-polar disorder. A true and correct copy of the Texas Board's Agreed Order is attached to this document as Exhibit A. Exhibit A is incorporated into this document by reference.
- 4. In resolution of this matter, Dr. Werner consents to the entry of the following Conclusions of Law and Order.

#### **CONCLUSIONS OF LAW**

- 1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).
- 2. The conduct described in paragraph 3, above, constitutes a violation of Wisconsin Administrative Code § Med 10.02(2)(q).

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the stipulation of the parties is approved.

#### IT IS FURTHER ORDERED that:

- 1. The license of Timothy H. Werner, D.O. (license # 21-23340) to practice medicine and surgery in the State of Wisconsin is hereby indefinitely SUSPENDED.
- 2. Timothy H. Werner, D.O. may after the return of an unrestricted license in the State of Texas, petition for an end to the indefinite suspension. In conjunction with any such petition, the Board may require the Respondent to appear in person before the Board and may impose terms, conditions and limitations on a return to practice in Wisconsin.
- 3. Respondent shall, within sixty (60) days from the date of this Order, pay costs of this proceeding in the amount of TWO HUNDRED dollars (\$200.00). Payment shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed to:

- 4. In the event Respondent fails to timely pay costs as ordered, Respondent's license (#21-23340) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order. The Board or its designee will remove the suspension, if provided with sufficient information that Respondent is in compliance with the Order and that it is inappropriate for the suspension to remain in effect. The Board in its discretion may impose additional conditions and limitations for a violation of any of the terms of this Order.
- 5. Respondent is responsible for compliance with all of the terms and conditions of this Final Decision and Order.
- 6. This Order is effective on the date of its signing.
