This matter came before the Board at its regular and properly noticed meeting on December 14, 2005. The appearances were Arthur Thexton, Prosecuting Attorney, respondent in person, and respondent's attorneys, Patrick Knight and Paul Erickson. The Board received an affidavit of Arthur Thexton, four patient charts (representing Counts I-IV of the Petition), and a written submission including reference materials from Mr. Erickson. Oral presentations were made by Mr. Thexton and Mr. Erickson. Respondent made a statement and answered questions asked by members of the Board.

FINDINGS OF FACT

- 1. Respondent Jae Yong Shim (dob 6/12/39) is and was at all times relevant to the facts set forth herein a physician and surgeon licensed in the State of Wisconsin pursuant to license #34797, first granted on 8/25/93. Respondent is a psychiatrist and neurologist, and is the medical director or attending psychiatrist at several outpatient mental health clinics in the Milwaukee area. Respondent's address of record is 19300 W. Observatory Rd., New Berlin, WI 54146-3412.
- 2. There is probable cause to believe that respondent is an immediate danger to patients and the public. Respondent's conduct is such that the public health, safety and welfare imperatively require emergency suspension of respondent's license until such time as respondent can demonstrate that he can practice with skill and safety to patient and public.
- 4. A formal Complaint alleging that respondent has committed unprofessional conduct has been filed, and an Amended Complaint has been presented to the Board. The Board finds that the Amended Complaint states probable cause that unprofessional conduct has occurred.
- 5. Respondent was informed of this Notice and Petition for Summary Suspension on December 8, 2005, by having the documents e-mailed to his attorney; they were then delivered personally to his attorney on December 9, 2005.

CONCLUSION OF LAW

The legal requirements for summary suspension pursuant to Wis. Stat. § 448.02(4), have been fulfilled.

ORDER

NOW, THEREFORE, IT IS ORDERED: the license of Jae Y. Shim, M.D., to practice medicine and surgery is SUSPENDED for thirty days. Respondent shall surrender his credentials to the Board or any department staff requesting them, forthwith.

IT IS FURTHER ORDERED, that the Amended Complaint shall be filed, and a hearing held.

IT IS FURTHER ORDERED, that authority to extend this suspension pursuant to Wis. Stat. § 448.02(4), is delegated to the Administrative Law Judge in this matter.
