PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Rebecca S. Camren, L.P.N., (DOB 07/28/1971) is duly licensed as a practical nurse in the State of Wisconsin (license #31 32766). This license was first granted on 10/21/1994.
2. Respondent's most recent address on file with the Wisconsin Board of Nursing is 3637 Brigham Avenue, Madison, Wisconsin.
3. At all times relevant to this action, Respondent was working as a practical nurse in Wisconsin.
4. On December 17, 2003 Respondent called in a false prescription for herself for Hydrocodone, giving a false name and using a doctor's name and DEA number without his permission. Respondent picked up the Hydrocodone and was arrested as she left the pharmacy.

5. Respondent's prosecution was deferred pending her completion of the Drug Treatment Court Program. Respondent completed the Drug Treatment Court Program in December of 2004.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07,[\[smg1\]](#) and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

2. The conduct described in paragraphs 4 - 5 above constitutes a violation of Wisconsin Administrative Code § N 7.04(1) and (2)

ORDER

IT IS ORDERED:

1. The stipulation of the parties is approved.
2. The Board of Nursing accepts the surrender of the license of Rebecca Camren, L.P.N. (license #31 32766), to practice as a nurse in the State of Wisconsin.
3. In the event that Ms. Camren re-applies for Wisconsin licensure as a nurse in the future, the Board may enter an order denying such application without further notice or hearing.
4. This Order shall become effective upon the date of its signing.
