PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Respondent David Joseph Czarnecki (dob 10/14/49) is and was at all times relevant to the facts set forth herein a physician and surgeon licensed in the State of Wisconsin pursuant to license #25913, first granted on 7/1/84. Respondent is a diagnostic radiologist and is certified by the American Board of Radiology.
- 2. During the year 1996 with respect to his wife, and then from 2002-2004 with respect to family members and one family friend, Respondent engaged in the treatment of family and one family friend by dispensing legend and controlled substances to them. Respondent ordered these medications from licensed distributors and stored them at his place of hospital employment except for a brief period in 2004 after he changed jobs, when he stored them in his home, dispensing them as needed. He did not keep patient health care records for any of the persons to whom medication was dispensed. He did not keep records of the receipt, dispensing, return, or other disposal of the medications. He did not store the controlled substances at all times in a locked, substantial, and secure container. He did not take any biennial inventories of the controlled substances in his possession. The medications included hydrocodone products (liquid and pills), and small quantities of alprazolam and zolpidem.
 - 3. Respondent has undergone a comprehensive residential evaluation at Rush Behavioral Health, and no evidence of present or historic impairment or substance abuse was found.
- 4. Respondent's DEA registration is the subject of a Letter of Agreement, by which Respondent agreed not to purchase any controlled substance from any distributor or vendor, to be delivered personally to him for use outside of his regular practice at his place of employment.
- 5. Respondent has personally attended and successfully completed the following courses: The 40 hour "Intensive Course in Controlled Substance Management" by Case Western Reserve University, School of Medicine, Continuing Medical Education; and the 16 hour "Intensive Course in Medical Ethics and Professionalism" by Case Western Reserve University, School of Medicine, Continuing Medical Education.

CONCLUSIONS OF LAW

- A. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- B. The conduct described in ¶2, above, violated Wis. Adm. Code § Med 10.02(2)(z) and (za), § Med 17.05(1) and (2), § Med 21.03(1) and (2), and § Phar 8.02(1), (2), and (3). Such conduct constitutes unprofessional conduct within the meaning of the Code and statutes.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is accepted.

IT IS FURTHER ORDERED, that David Joseph Czarnecki, M.D., is REPRIMANDED for his unprofessional conduct in this matter.

IT IS FURTHER ORDERED, that respondent shall pay the COSTS of investigating and prosecuting this matter of \$950. It is acknowledged that respondent has paid this amount.
