PROCEDURAL HISTORY

The parties in this matter agree to the terms of the attached Stipulation as the final decision of this matter, subject to the approval of the Department Secretary. The Department Secretary has reviewed this Stipulation and considers it acceptable.

The Department Secretary adopts the attached Stipulation and makes the following findings of Fact, Conclusions of Law, and Order

FINDINGS OF FACT

- 1. Dawn Saengphaphat ("Respondent") is not and was not at any time relevant to this action, licensed to provide manicuring services in the State of Wisconsin.
- 2. Respondent's last reported address on file with the Department of Regulation and Licensing ("Department") is: 1036 N. 18th Street, Manitowoc, Wisconsin 54220.

- 3. On or about March 15, 2005, an inspection was performed at Regal Nails, a licensed manicuring establishment in the State of Wisconsin (#071 002213). An investigator with the Department observed the Respondent providing manicuring services to a patron. At the time of the inspection, the Respondent had not obtained a manicurist license to provide such services.
- 4. Currently, disciplinary action is pending against Regal Nails and its owner, Nikki Nguyen for assisting and engaging in unlicensed practice by allowing the Respondent to provide manicuring services without first obtaining a Wisconsin manicurist license.
- 5. Respondent understands that in order for her to provide manicuring services, she must first obtain a manicuring license.

CONCLUSIONS OF LAW

- 1. The Department of Regulation and Licensing has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.21.
- 2. The Department of Regulation and Licensing is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 3. Respondent Dawn Saengphaphat has violated:
 - Wis. Stat. § 454.04(1)(d) by providing manicuring services without first obtaining a manicuring license.

ORDER

NOW THEREFORE, IT IS ORDERED THAT Dawn Saengphaphat, is ENJOINED and PROHIBITED as follows:

- 1. DAWN SAENGPHAPHAT SHALL NOT PRACTICE OR OFFER TO PRACTICE MANICURING, UNTIL SHE FIRST OBTAINS A MANICURING LICENSE.
- 2. Violation of the order described in Paragraph one (1) above may result in a forfeiture of up to \$10,000 for each offense, and each day of a continued violation constitutes a separate offense. Violation of the order described in Paragraph one (1) above may also result in a referral to the local office of the District Attorney or Attorney General for further action.
- 3. This order shall become effective on the date of its signing.
