PROCEDURAL HISTORY

On August 28, 2001, the Department of Regulation and Licensing issued its Order Adopting the Stipulation in the above-captioned matter. By the terms of the Department's order, applicant's license (#108-18526) to practice private security in Wisconsin was granted under certain limiting conditions. The Order provided that failure by applicant to timely comply with the terms of this limitation and/or any further criminal conviction shall result in the revocation of applicant Patzer's limited private security permit.

On September 9, 2005, the Department found that Mr. Patzer had failed to file the necessary quarterly reports with the Department. The Department also found that according to the Wisconsin Circuit Court Access website, Mr. Patzer was charged with two crimes in 2002, which he failed to report to the Department. Mr. Patzer was subsequently convicted of one of the charges in 2003, which he failed to report to the Department.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the limited private security permit of Donald Patzer (#108-18526) is REVOKED.

This Order shall become effective upon the date of its signing.
