The Department of Regulation, having considered the entire record of the matter, makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1) Robert L. Bradford (Applicant) filed an application for a private security permit, on or about September 15, 2005.
- 2) On September 28, 2005, the Department of Regulation and Licensing served by mail to Applicant a Notice of Intent to Deny and Notice of Right to Hearing on Credential Denial dated September 27, 2005. As a part of the Notice of Intent to Deny, the Department of Regulation and Licensing informed Applicant that he had 45 calendar days from the date of the mailing of the notice to submit additional information and/or to request a hearing on the denial of his application.
- 3) Applicant submitted a request for hearing on the denial of his application by letter postmarked November 16, 2005 and received by the Department on November 17, 2005.
- 4) The time for submission of an appeal of the denial of Applicant's application expired on November 14, 2005.

CONCLUSIONS OF LAW

- 1) The Department of Regulation and Licensing has jurisdiction in this matter under Wis. Stat. ch. 440, Subch. II: Private Detectives, Private Security Persons.
- 2) Applicant has failed to timely file a request for hearing, as required by Wis. Admin. Code §§ RL 1.05(1)(b) and RL 1.07.

ORDER

NOW, THEREFORE, IT IS ORDERED that Applicant's Request for Hearing is DENIED.
