ORDER DENYING RENEWAL OF
LIMITED LICENSE

On June 9, 2005, the Board of Nursing considered the petitioner's request for renewal of his registered nurse license (#67972), which was limited by the Board Order dated October 3, 1988, currently in effect. The petitioner was required to obtain a chemical dependency assessment at a treatment facility acceptable to the Board, and if dependency was not found to exist, a limited license would be issued. The limitations upon the license included the submission of written quarterly work reports from petitioner's nursing employer. Upon satisfactory work performance for a period of two years, the limitations were to be terminated. If the assessment indicated that petitioner was chemically dependent, the petitioner was to be required to participate in outpatient counseling and treatment pre-approved by the Board. The order further required quarterly written progress reports from his treater. Upon successful compliance with treatment for a period of two years, a full license was to be granted. The record indicates that petitioner has failed to comply with the terms and conditions of his limited license. Based upon all of the information presented, the Board of Nursing makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request to renew the license of Gary L. Campbell (#67972) to practice as a registered nurse is hereby DENIED and the license issued to petitioner is REVOKED.
