On April 14, 2005, the Wisconsin Board of Nursing considered the petitioner's request for reinstatement of his suspended registered nurse license (# 0106445). Based upon all evidence of record herein indicating that the petitioner has not fully complied with terms of the original Board order dated July 7, 1995, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the license of GREGORY J. DICKERT (lic. #0106445) to practice as a registered nurse in Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that petitioner may be granted a limited license provided that he submits:

- (1) a current psychological evaluation and AODA assessment with a statement by his evaluators of his fitness to practice;
- (2) proof of six months compliance with random weekly drug and alcohol testing, (total of 30 tests), which shall include ETG testing for alcohol.

IT IS FURTHER ORDERED that upon submission and satisfactory review of the Board of the materials set forth above, petitioner may be first granted a limited license to take a Board-approved nurse refresher course.

IT IS FURTHER ORDERED that upon passage of the refresher course, petitioner shall enter into a stipulation with the Board of Nursing for a standard five (5) year impairment order and may be granted a limited license to practice nursing pursuant to the terms of that order.

This order is effective upon the date signed below.
