On July 14, 2005, the Board of Nursing considered petitioner's request for reinstatement of her limited license and a stay of suspension, pursuant to the Board order dated March 5, 1999. Based upon all information of record herein, the Board now finds and makes the following:

#### ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement and a stay of suspension of the license of LORI J. KLEMP, R.N., (lic.#107915), to practice as a registered nurse is hereby DENIED. The reason for the denial is the lack of current comprehensive health care information for petitioner.

IT IS FURTHER ORDERED that petitioner shall submit a current AODA assessment and mental health evaluation, with an overview of her current status and treatment, the names of her current health care providers and a list of her current medications.
