On June 9, 2005, the Wisconsin Board of Nursing considered the request of the petitioner, Heidi L. River, R.N., for a further three month stay of the suspension, pursuant to the Order dated April 2, 2001, currently in effect. The petitioner also requested a decrease in her random urine screens. Based upon all information of record herein, showing that the petitioner is in compliance with the terms and conditions of her limited license and there is support for the modification of her urine screens, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a stay of the suspension of the limited license of HEIDI L. RIVER, R.N., (lic. #124862) to practice as a RN in the state of Wisconsin is hereby GRANTED for a period of three months.

IT IS FURTHER ORDERED that the request for a modification of her random urine screens is GRANTED. The urine screens shall be at a frequency of 42 times per year.

This Order is effective upon the date of signing and is continuous from the granting of the previous stay.
