On June 23, 2005, the State of Wisconsin Chiropractic Examining Board reviewed the documentation presented in support of the request by Randal E. Arnold, D.C., for a termination of suspension, termination of limitations and full reinstatement of licensure as provided in the Board's Final Decision and Order dated September 2, 1999. Included in the documentation was a report from Dr. Charles M. Lodl, PhD.

Based upon the Board's review;

IT IS HEREBY ORDERED that the request of Randal E. Arnold D.C., request for termination of the requirement for continuing psychotherapy is GRANTED.

IT IS FURTHER ORDERED THAT the respondent shall obtain a successor Mentor subject to approval of the Board who shall review the respondent's compliance with the limitations and requirements of the Final Decision and Order dated September 2, 1999 and Order Terminating Suspension, Imposing Limitations, and Reinstating License dated March 24, 2003. The Mentor shall monitor the Respondent's compliance with the Policies and Procedures including the Surveillance Form and the Patient Survey Form adopted by the Board in the March 24, 2003 order. The Mentor shall submit reports in writing to the board every three months on Dr. Arnold's participation and compliance.

IT IS FURTHER ORDERED that all other limitations not modified herein shall remain in effect including the requirement that the Respondent bear the expense of the Mentor.
