On September 8, 2005, the Wisconsin Board of Nursing considered the petitioner's request for reinstatement of her registered nurse license (# 125685), which had been limited pursuant to the order of the Board dated November 5, 1999. Based upon all evidence of record herein indicating that the petitioner has not been compliant with the terms and conditions of the Board order requiring that she obtain board pre-approved remedial education in nursing ethics, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the limited license of CATHERINE A. LEVELIUS (# 125685), to practice as a registered nurse in Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that Petitioner must fulfill the original Board requirements prior to requesting reinstatement of her nursing license.
