ORDER DENYING FULL
REINSTATEMENT OF LICENSE

On February 3, 2005, the Wisconsin Professional Engineer Section considered the petitioner's request for full reinstatement of his limited professional engineer license in the state of Wisconsin. Petitioner's request was submitted pursuant to terms of the Final Decision and Order dated March 3, 2000. Based upon all information of record herein, including petitioner's letter dated September 17, 2004, which states that he has not been involved in any engineering practice in Wisconsin for over six years and information that petitioner has, therefore, not completed any of the requirements for supervision and evaluation of his practice as required under the Board's original order, the Board now finds and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of unlimited licensure of the limited license of Richard B. Klein, (lic. #25917) to practice as a professional engineer (PE) in Wisconsin is hereby DENIED. The basis for the denial of petitioner's request is his failure to satisfy the requirements of the Board's original order for supervision and evaluation of his practice in Wisconsin.

IT IS FURTHER ORDERED that petitioner may reapply and be granted full reinstatement at the time of the next biennial renewal, provided that he submits proof with his request showing that he has not been professionally disciplined by any other jurisdictions where he currently holds a professional engineer license.

IT IS FURTHER ORDERED that in the alternative petitioner may voluntarily surrender his PE registration in the state of Wisconsin in lieu of completing the requirements of the original order or the requirements set forth herein for full reinstatement at the time of the next biennial renewal.
