On March 16, 2005, pursuant to the Order currently in effect, the Wisconsin Medical Examining Board considered the petitioner's request for reinstatement of his limited license and his request for modifications of his therapy and urine screens. Based upon all information of record herein, the Board finds that the petitioner has shown sufficient compliance with the terms and conditions of the Board order to warrant a stay, but insufficient support for the other modifications, therefore, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three months stay of the suspension of the limited license of license of BENJAMIN W. BEGLEY, MD (lic. 20-29405) is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for modifications to the order is DENIED.

IT IS FURTHER ORDERED that petitioner shall refrain from having the office manager sign his quarterly work supervisor reports.

This Order is effective upon the date of signing and shall be continuous from the date of the previous stay.
