On May 18, 2005, the petitioner appeared before the Wisconsin Medical Examining Board to request a further three month stay of the suspension of his limited license (#20-29405) and modifications in his board order dated June 16, 2004, which is currently in effect. Based upon all information of record herein, the Board finds that the petitioner has shown sufficient compliance with the terms and conditions of the Board order to warrant a further three month stay of suspension and to warrant modification of his therapy and mentoring requirements, therefore, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the limited license of license of Benjamin W. Begley, M.D. (lic.# 20-29405) is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for the following modifications to his board ordered therapy requirements are APPROVED.

1. Steven Roberts is approved as the respondent's AODA counselor.
2. Dr. Hunusa or Dr. Tossone are approved as possible mentors for respondent.
3. Respondent will continue to see Dr. Goldstone on a quarterly basis as his supervising health care provider pursuant to the terms of the order.

This Order is effective upon the date of signing and shall be continuous from the date of the previous stay.
