The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable. Accordingly, the Department in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Craig D. Schick has never been licensed as a real estate appraiser in the State of Wisconsin pursuant to Chapter 458 of the Wisconsin Statutes.
 - 2. In the summer of 2005 Gregory Moriva supervised Mr. Schick in preparing appraisals.
- 3. On or about August 1, 2005, Mr. Moriva notified Mr. Schick that he did not have time to supervise him any longer and severed their relationship. Mr. Moriva signed off as Mr. Schick's supervisor for approximately five appraisals. The last appraisal that Mr. Moriva supervised and signed off on for Mr. Schick was dated August 1, 2005.

- 4. On or about March 20, 2006, Mr. Moriva was contacted by Community One Mortgage regarding a question they had on an appraisal submitted by Mr. Schick which contained Mr. Moriva's name as supervisor. It was at that time that Mr. Moriva realized that Mr. Schick had continued to use Mr. Moriva's electronic signature even after he told Mr. Schick he could no longer supervise him.
- 5. Appraisal reports filed by Mr. Schick containing Mr. Moriva's signature as supervisor after August 1, 2005, include the following:

Appraisal for Richard Parsons, 440 S. Pleasant St., Whitewater, invoice number 12282005, date of invoice 12/28/05;

Appraisal for Linda Santos, 216 N. Morris St., Stoughton, invoice number 5371111032005, date of invoice 11/03/05;

Appraisal for Brandon and Michelle Green, W5404 Drake Rd., Rio, invoice 11082005, date of invoice 11/08/05;

Appraisal for Katey Chronister, 682 E. Countryside Dr. Evansville, invoice 10312005, date of invoice 10/31/05;

Appraisal for Christine A. Anderson, 8604 W. Lynx Ave., Milwaukee, no invoice number, date of invoice 2/10/06; and

Appraisal for Timothy Waldron, 1300 E. South St., Stoughton, invoice date invoice date 01/20/06.

- 6. As part of the appraisal report Mr. Schick filed for property at 924 Prairie Garden Drive in Kewaskum, he included a photocopy of Mr. Moriva's license. When issued, the license contained an expiration date of 12/31/2005. The copy filed by Mr. Schick contained the expiration date of 12/31/2006.
- 7. Mr. Moriva alleges that Mr. Schick forged his original signature in red ink which he never uses, on an appraisal on at least one occasion.
- 8. Mr. Schick stated that the appraisals were "practice appraisals", meaning that they were not done for a client. An employee at Community One Mortgage sated that they were ordered from Mr. Schick for mortgage loan applications, and that one or more of the appraisals that Mr. Schick completed without a supervising appraiser were completed for federally funded transactions, which is a violation of 12 USC 3349, for which the financial institution can be held responsible.
- 9. On or about January 19, 2006, Mr. Schick completed an appraisal for property located at 1300 E South St., Stoughton, WI. Mr. Schick signed this appraisal as appraiser and included a Wisconsin License number of 1901-004 under his name. Mr. Schick included a photocopy of a license containing license number 1901-004, expiring 12/31/2006, in the name of Craig D. Schick. This license number is not assigned to Mr. Schick or Mr. Moriva but assigned to another real estate appraiser. Mr. Schick was not authorized to use this number. The signature line for "Supervisory Appraiser" is blank.

CONCLUSIONS OF LAW

- 1. The Wisconsin Department of Regulation and Licensing has jurisdiction over this matter pursuant to Wis. Stat. § 440.21(1) and (2).
- 2. The Wisconsin Department of Regulation and Licensing is authorized to enter into this stipulated resolution of this matter pursuant to Wis. Stat. § 227.44(5).
- 3. Pursuant to Wis. Stat. § 458.055(4) "no person may describe or refer to an appraisal of real estate located in this state by the term "Wisconsin Licensed" or any similar term unless the person is a certified appraiser or licensed appraiser."
- 4. Respondent, Craig D Schick, has engaged in activities that constitute the practice of real estate appraisal in the State of Wisconsin in violation of Wis. Stat. Chapter 458.

ORDER

from the practicing real estate appraisal or using a protected title without a license in the State of Wisconsin.

IT IS FURTHER ORDERED that Respondent, Craig D Schick, be, and hereby is, notified that any person who violates a special order such as this, after it is issued under §440.21, Wis. Stats., may be required to forfeit not more than \$10,000.00 for each offense, and that each day of continued violation constitutes a separate offense.
