RELEVANT FACTS AND VIOLATIONS

On October 25, 2004, the Department of Regulation and Licensing issued its Order Adopting the Stipulation in the above-captioned matter. By the terms of the Department's order, applicant's license (#94-61805) to practice as a real estate salesperson in Wisconsin was granted under certain limiting conditions. The Order provided that upon receipt of verified documentation of a criminal conviction or probation violation subsequent to this Order, the department monitor may issue an order for the revocation of Mr. Noah's limited real estate salesperson's license without further notice or hearing or other proceedings.

On December 16, 2005 the Department received documents from Mr. Noah's probation officer stating that his probation supervision was revoked as a result of December 20, 2004 criminal charges. Mr. Noah was convicted of Operating while Under Influence (3rd) on December 19, 2005. Mr. Noah has failed to file required reports with the Department on March 1, 2005, June 1, 2005, September 1, 2005, and December 1, 2005. These acts violate paragraphs 1, 3, and 5 of the October 25, 2004 order.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the limited salesperson's license of Jason M. Noah (#94-61805) is REVOKED.

This Order shall become effective upon the date of its signing.
