On December 9, 2002, the Department of Regulation and Licensing issued an Order granting Respondent a limited license (#122598) to practice as a private security person in Wisconsin. The Order provided that failure by Respondent to timely comply the terms of this limitation would result in the revocation of Respondent's limited private security permit.

Mr. Tadder has failed to file required quarterly reports with the Department.

REVOKED.
