**PROCEDURAL HISTORY**

On October 22, 2004, the Department of Regulation and Licensing issued an Order granting Respondent a limited permit (#10 12567) to practice as a private security person in Wisconsin. The Order provided that failure by Respondent to timely comply the terms of the limitation as specified in the Order would result in the revocation of Respondent's limited private security perso permit.

Respondent ceased filing required quarterly reports with the Department in November 2005. Mr. Brown was charged with tw criminal offenses on December 28, 2005 which he failed to report to the Department, also in violation of the October 22, 2004 Order.

**ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the limited private security person's permit of Brian K. Brown (#108- 12567) is REVOKED.

This Order shall become effective upon the date of its signing.
