PROCEDURAL HISTORY

On January 24, 2001, the Department of Regulation and Licensing issued an Order granting Respondent a limited permit (#108-16675) to practice as a private security person in Wisconsin. The Order provided that failure by Respondent to timely comply the terms of this limitation and/or further criminal conviction would result in the revocation of Respondent's limited private security permit without further notice, hearing or other proceedings.

Mr. Mercer has failed to file required quarterly reports with the Department.

Mr. Migach was convicted of a criminal offense in July 2002, which he failed to report to the Department.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the limited private security permit of John M. Mercer (#108-16675) is REVOKED.

This Order shall become effective upon the date of its signing.
