**PROCEDURAL HISTORY**

On November 30, 2001, the Department of Regulation and Licensing issued an Order granting Respondent a limited license (#19385) to practice as a private security person in Wisconsin. The Order provided that failure by Respondent to timely comply the terms of this limitation and/or further criminal conviction would result in the revocation of Respondent's limited private security permit.

Mr. Migach has failed to file required quarterly reports with the Department.

Mr. Migach was convicted of two counts of Disorderly Conduct in October of 2004, which he failed to report to the Department.

**ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the limited private security permit of James Migach (#108-19385) is REVOKED.

This Order shall become effective upon the date of its signing.
