On April 12, 2006, the State of Wisconsin Pharmacy Examining Board reviewed the petition of Michael J. O'Kray, R.Ph., for the restoration of a full unlimited license to practice pharmacy in the State of Wisconsin, as provided within the board's *Final Decision and Order* ("Order") July 11, 2000. The *Order* provides in part:

IT IS FURTHER ORDERED that effective on the date of this Order, the pharmacist license of respondent is SUSPENDED for a period of not less than five (5) years. The Board in its discretion may restore respondent's license to full, unlimited status only upon petition by respondent after completion of five years of practice of pharmacy in compliance with all terms and conditions of this Order, and a demonstration that respondent may practice pharmacy without condition or limitation with skill and safety to patient and public.

Also sought was an alternative order for a stay of suspension and that O'kray be allowed to open and close a pharmacy consecutively as a pharmacist in charge. The board reviewed O'kray's monitoring history and determined that he has not completed five years of the practice of pharmacy in compliance with the Order. Based upon the board's review:

IT IS HEREBY ORDERED: that Michael J. O'Kray, R.Ph., is granted a three month stay of the suspension of license #9415, to practice pharmacy in the State of Wisconsin, and is denied an unlimited license, #9415, to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that Michael J. O'Kray, R.Ph., may open and close a pharmacy consecutively as a pharmacist in charge.
