ORDER RESTORING FULL CREDENTIAL

On December 6, 2000, the Social Work Section (Section) issued a *Final Decision and Order* in the above-captioned matter. Under the terms of the Board's Order, Ms. Ripp's social worker certificate was suspended. The Order further provided that she complete ethics' coursework and undergo a mental health assessment.

On March 29, 2006, the Section reviewed the request of Mary Jane Ripp, C.S.W., for the return of her certificate as a social worker without restrictions pursuant to the Section's *Final Decision and Order*. Therefore, based upon evidence of Ms. Ripp's compliance with the terms and conditions placed upon her,

IT IS HEREBY ORDERED that all the limitations on the credential of Mary Jane Ripp to practice as a certified social worker in Wisconsin are lifted and her certificate is restored in full.
