On June 22, 2006, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Thomas G. Pire, R.Ph., for a three-month stay of suspension of his license to practice pharmacy, as provided by the terms of the board's *Final Decision and Order*, ("*Order*") dated October 10, 2001. (Pire began practicing pharmacy under the *Order* June 1, 2004.) Requested was a reduction in urine specimen testing to 48 times each year and the granting an additional four (4) hours per week to be worked as a pharmacist in charge, (currently at 16), and the request that he be allowed to open and close a pharmacy on the same day. Also requested was a reduction in individual/group therapy as required by paragraph 2.b.(3) of the *Order* to one time per month. Based upon the board's review:

IT IS HEREBY ORDERED: that Thomas G. Pire, R.Ph., is granted a three-month stay of the suspension of license # 9468 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that Thomas G. Pire, R.Ph., is denied an additional four (4) hours per week to be worked as a pharmacist in charge.

IT IS FURTHER ORDERED: that the request for a reduction in urine specimen testing to 48 times each year is granted.

IT IS FURTHER ORDERED: that the request for individual/group therapy as required by paragraph 2.b.(3) of the *Order* to one time per month, is granted.
