ORDER GRANTING THREE MONTH STAY WITH MODIFICATION

On April 20, 2006, Board of Nursing considered the petitioner's request for full reinstatement of her nursing license or, in the alternative, a further three month stay of the suspension of her license. The petitioner also requested modification of her therapy sessions and random urine drug screens. Based upon all information of record showing petitioner has not fulfilled the requirements for full reinstatement and does not have therapist support for the modifications, the Board finds and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of suspension of the registered nurse license of Robin Swiggum (lic. #119898) in the state of Wisconsin is hereby GRANTED.

IT FURTHER ORDERED that the petitioner's request for full reinstatement and a decrease in her therapy and random urine drug screens is DENIED.

IT IS FURTHER ORDERED that the petitioner is GRANTED access to controlled substances in her workplace.

This Order is effective upon the date of signing and the stay is continuous from date of the previous stay.
