#### PROCEDURAL HISTORY

On July 12, 2006, the State of Wisconsin Dentistry Examining Board reviewed the petition by John by John F. Reed, DDS, for modification of conditions, as provided in the Board's Final Decision and Order dated May 5, 2004.

#### FINDINGS OF FACT

- 1. On March 6, 2002, the Dentistry Examining Board imposed discipline upon the license to practice dentistry of John F. Reed, DDS (DOB 01-17-1958). Dr. Reed's address of record with the Department of Regulation and Licensing is 1241 Lombardi Access Road, Green Bay, WI 54304.
- 2. Dr. Reed has cooperated with the Department Monitor and has maintained compliance with the terms of the license limitations imposed by the Board's Order.
- 3. On July 12, Dr. Reed's petitioned the Board a routine stay of suspension of his license. In addition, Dr. Reed petitioned for a reduction in the number of annual urine screens required of him under the terms of the Board's order.

#### CONCLUSIONS OF LAW

The Dentistry Examining Board has jurisdiction and authority in this matter, pursuant to Wis. Stat. § 447.06.

#### ORDER

Based upon the Board's review, IT IS HEREBY ORDERED that:

- 1. IT IS HEREBY ORDERED that John F. Reed DDS, is GRANTED a three month stay of the suspension of license 3877 to practice as a Dentist in the State of Wisconsin. Please be advised that the submission of the next quarterly reports and petition for extension of stay of suspension are due on **October 15, 2006**.
- 2. The FREQUENCY of required drug screens for Dr. Reed is hereby REDUCED to forty-two [42] random screens per annum.

All other requirements of the original Final Decision and Order remain in full force and effect.
