On December 14, 2006, the Board of Nursing considered the Petitioner's request for a reinstatement of her nursing license and a three month stay of the suspension. Petitioner also requested modification of her Board order to allow her access to controlled substances at her workplace and a reduction in her therapy sessions. Based upon all information of record showing Petitioner is now in compliance with her order, the Board finds and orders as follows:

<u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement and a three month stay of suspension of the license of BARBARA J. BENOIT, (lic. # 82241) to practice as a registered nurse in Wisconsin is hereby GRANTED. IT IS FURTHER ORDERED that the request for modification of Petitioner's order to reduce therapy and allow access to controlled substances is hereby DENIED due to her recent non-compliance with her random drug and alcohol testing procedure.
