On September 12, 2006, the Board of Nursing considered the petitioner's request for a three month stay of the suspension of her limited license and modification of her Board order. Based upon all information of record herein showing petitioner's non-compliance with the call-in procedure for her random drug and alcohol testing, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of suspension of the license of BARBARA J. BENOIT, (lic. # 82241) to practice as a registered nurse in Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that the request for modification of petitioner's order to reduce her therapy sessions and allow access to scheduled medications in the workplace is hereby DENIED.
